P-Card charges are assigned to each cardholder's statement.



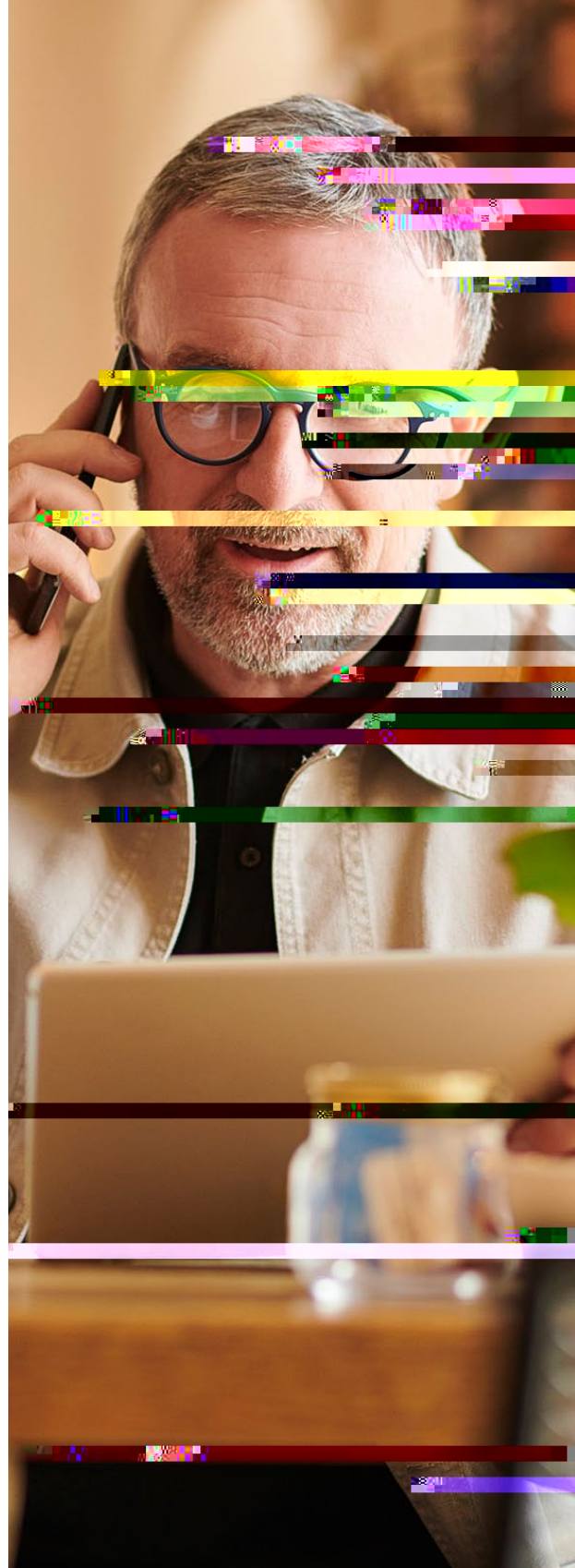
Automatically assign
